- Important trends this year
 - o drop in teams; associations have to work on this AND reduce costs
 - o drop in volunteers
 - o drop in Midget and Bantam teams and players
 - AAA restructuring in the greater City of Sudbury whereby NCity and SMHA are combining teams at Bantam and Midget levels for at least a one-year test
- League issues that the Executive will work on:
 - Matching caliber of teams, while providing variety of competition to the teams is a delicate issue
 - developing pre AAA aged players in Atom and Novice; this year NCity Novice AA were allowed to move up to Atom II; mixed feelings as to whether this was best for these players;
 - The transition from initial Round Robin schedules to Part II of the schedules, after team movement (if any), will be better balanced

Playoff Winners-

- League: of 8 active associations, every Association had at least one team make it to one of the 15 Championships; NCity won 7 Championships, followed by CCliff with 3
- 15 of our league's teams either won championships or were finalists at the NOHA Tournament of Champions.

 - Amendment passed

8. Changes to Rules and Regulations being considered:

- changing midget games to 1.5 hour slots as opposed to 2 hours. Would be a 2 period flood; "Bantam rules"; discussion on the floor was positive to this change
- Team fees might be increased slightly; \$10-\$25 per team; no comments of opposition from the floor
- Consideration of the pre-game warm up from 4 minute to 3 minute warm up; no comments of opposition from the floor
- New Affiliation rules (Section 4-Rule 7)
 - Discussion only on part (a) of this amendment whereby the Executive feels that teams should not be allowed to draw affiliate players, for League games, from teams who compete in the same Division
 - o This will be discussed further throughout the summer
- Other minor housekeeping changes in wording in the R&R
