4 Minutes of Annual Meeting - May 13, 2014

ACCEPTED by Peter Nikilchuk (SMHA) Seconded by Jim Hall (West Ferris)

- **Financial Report**: Joe McColeman As the League does not have a Treasurer at this time, Financial Statements have not been prepared, therefore only a verbal presentation
 - Bank balance had some changes (approx. \$500) mileage for Director travel to AGM, NOHA fees paid, one jacket for one Executive member paid for
 - GIC no change
 - No move to accept- deferred- financial statements will be sent to Associations after a Treasurer is put into place
- Report of Team Review Committee Met on May 28/14 to look at 59 declared teams
 - after review number dropped to 45 teams approved.
 - Of the teams declared only 3 were not approved
 - Process works with review
 - 16 teams dropped out after review for many reasons and some associations came back
 - Still having trouble with declining numbers with Midgets and Bantams due to choice of High School hockey and/or houseleague

8 **League Business:**

Changes to League Constitution- no changes to League Constitution- current 2014 Rules and Regulation (2014 AGM) - Re-written in April; sent out to Associations

April 18/14- nochanges needed to be submitted from Associations.

Reviewed some housekeeping items.

Competition Structure and Division Alignment- New divisional structure are now clearer, Within the Rules and Regs - incorporated policies and memorandums of understanding in place

If there are not enough teams in an age group, all teams will play an initial round robin schedule and then break off after.

This year Bantam will have to do this.

The playoff structure for varying sized divisions within the tournament is clearer in Explanation.

Rules and Regulations were reviewed

League Web-site www.ndmhl.ca – Usually up to date.

Reminders for team personnel (must things to do) –

Management Pledge forms due- Oct 15/14. There is a \$50 fine for each team that does not submit this prior to due date.

Fine for a game forfeit or cancellation without reason/no advance warning is up to \$400.

Fine for Coaches, Managers, Trainers due to excessive penalties 2nd occurrence \$50.

League Crests are available and need to be on the Right shoulder by Nov 1/14 or this incurs a \$50 fine.

Please refer to the OHF suspension list and adhere to penalties

Examples GM 50 is 3 games suspension

4th penalty in a game- Player is out of the game.

More than 60 mins(Midget/Bantam) of penalties- Head Coach is suspended.

40 minutes for ages under Bantam

Rescheduling forms – Both teams need to agree to the change and if the game needs to be postponed it should be done 14 days in advance. Finalization of arrangements (sometime during the year) should be rescheduled within 14 days of the date of cancellation.

Game reports need to be submitted to the Convenor within 7 days or a \$20 fine will be assessed.

Convenor selection: Atom II – will revisit with the teams themselves

Pee Wee II- Scott Rienguette and wife will handle along with PW I

Bantam II – single division with Bantam at this time
